EXHIBITORS MUST PROVIDE THEIR OWN CAGES, LITTER TRAYS & LITTER.

ALSO PLEASE ALSO TAKE NOTE OF THE FOLLOWING RULES:

Entries are only accepted by e-mail and e-mail attachments or fax. Payment is only accepted as direct deposits or internet transfer. Please e-mail or fax proof of deposit with entries.

All WCF titles and certificates are accepted, irrespective of continent or country.

All cats are entered with their original/initial registration number from any Cat Registering Association. All breeds of cat are entered in separate colour/pattern classes.

Ideally WCF exhibitors stay with and take care of their cats throughout the show. Cats are also taken to the judge and Best on Show by their owners or handlers. Stewards only assist the judge to call cats. Breeders may promote and advertise their catteries or other services at their cages. Cats may be groomed and handled at the benching area. Chairs, grooming equipment, etc. may be placed inside the rings.

KITTEN CLASSES: Two separate kitten classes constitute kittens between the ages of 3 – 6 months (kittens) & 6 – 10 months (juniors). Baby classes constitute kittens between the age of 10 weeks and 3 months. Babies can also be entered in the litter classes.

LITTER CLASSES: A litter class consists of several individuals from the same litter between the ages of 8 weeks and 3 months, exhibited and judged together. Individuals from a litter class can also be entered in the baby classes. The dam of the litter may be benched with the litter, but cannot be entered on the show, as she would still be a nursing mother.

NOVICE CLASS: An unregistered cat conforming to the standard of a recognised breed can be registered without a pedigree if entered in this class and two qualified judges agree that the cat is of sufficient quality to be accepted.

DETERMINATION CLASS: When an owner is unsure of the colour, pattern or coat length, or other aspect of a registered cat, it can be entered in this class. A qualified judge will provide a written report on the cat and advise on the correct classification and registration with WCF.

WCF RING: Three separate rings for Entire Adults, Neutered Adults and Kittens may be entered in addition to the standard show classes. All breeds and sexes compete for placing in the rings. Ring placings count towards further special titles and entitlement to enter an annual WCF Master Ring. See last pages for more details on Specials and WCF rings. ***Ring winnings will be used in future to calculate a National Best Cat competition and scores, as well as Exhibitor of the Year and Breeder of the Year, etc.***

REGISTRATION - Every cat or kitten exhibited in the championship section of this show must have been registered with a Cat Registering Authority prior to the closing date for entries to the show. If transferred to a new owner, the transfer must have been duly registered with the relevant Registrar prior to the closing date for entries to a show. Any kittens entered on a show and sold after the closing date for that show must be duly transferred in the 7 days before the date of the show, but the entry will remain in the name of the original exhibitor.

DOMESTICS USED FOR OUTCROSS BREEDING/UNRECOGNISED VARIETY: Entire domestic cats over the age of 10 months, used for outcross breeding, or cats of unrecognised variety or cross breeding may be exhibited in a special section of the domestic or non-championship section. They may be entered with or without a registration number and will be judged as domestic cats.

INOCULATION - All kittens and cats on show must have been inoculated initially. Photostat & scanned copies of such certificates will be accepted.

EXHIBITOR BOUND BY RULES - A person entering a cat for any show held under the WCF rules shall, by such act, be deemed to have agreed to refer any question or dispute to the show manager and to abide by his/her decision.

COMMUNICABLE DISEASES - No exhibitor shall exhibit a cat or kitten which to his/her knowledge has, at the date of the show, been exposed to a communicable disease within the period of 30 days prior to the date of the show, and no cat or kitten may be exhibited if the exhibitor had had any such illness in his or her home or cattery during that period. In the case of a communicable disease having occurred in a home or cattery, a veterinary clearance certificate will be required. Any exhibitor who, in the opinion of the show manager, shall have made a false declaration in respect of the above, will be liable to penalties under the powers of the show manager. Owners of rejected exhibits shall not personally attend any show within the prescribed period of 30 days unless in the possession of a veterinary clearance certificate which must be exhibited to the show manager on demand.

You can make a separate Best in Show for specific breeds, which must be made according to the rules for the BIS.

The winners of the BIS for the 4 categories and the winners of the BIS of special shows are allowed to participate in the Best of Best.

Please remember to place on stage a large WCF symbol and print this license on one of the first pages of the show catalogue.

Only exhibitions with licenses printed in the show catalogues prove they are really licensed and valid for WCF awards.

We would like to remind you on all those very important points:

ALL SHOWS MUST BE LICENSED and licenses must be printed in the show catalogues. The club will face disciplinary actions,

and at least a fine of Euro 200.- will apply if the club does not comply with this resolution.

Each show catalogue must include a page for the WCF, including the names and addresses of the Board-members.

In all World and International Shows with foreign judges or exhibitors, all announcements and cat calls during the show

and Best in Show ceremonies, MUST BE made also in English, not only in the native language of the country.

In WCF exhibitions cats cannot be judged more than once per day even in combined exhibitions with two or more WCF-clubs, under penalty of rules.

Please send the amended show-application, if you need to invite other judges, at least 6 weeks before the date of the exhibition.

A copy of this show catalogue, electronically or normal, with all results must be sent to the Chairman of the Show Commission, presently Paolo Veneziani, latest 10 days after the date of exhibition.

Please buy Certificate-numbers from the WCF treasurer in advance and send the C-numbers together with all the data

when requesting a license at least 6 weeks prior to the date of the exhibition.

A change of the place requires a new payment and a new C-number, a change of the date until 6 weeks before the exhibition is free.
